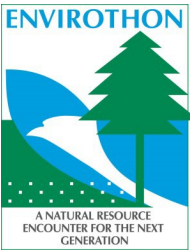

Congratulations to all the area teams who competed this year in area and state competitions. The Lower Republican NRD (LRNRD) is proud to support natural resource education!

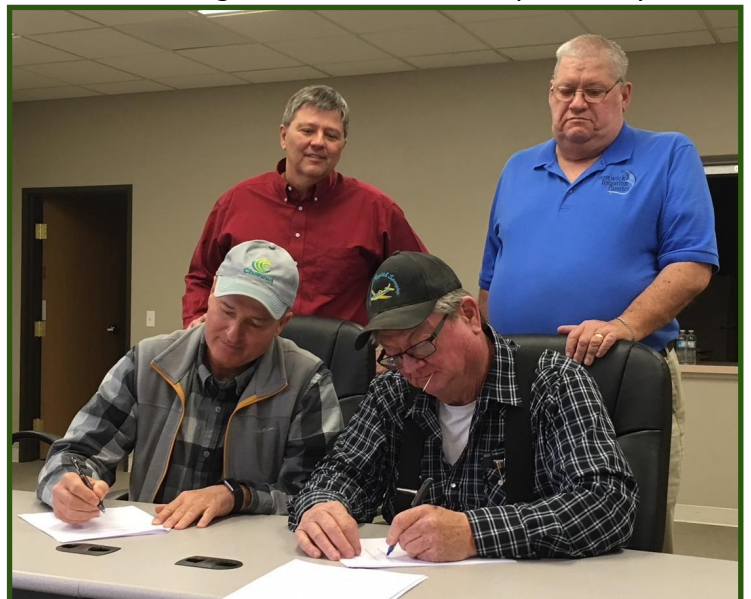
## Manager's Message By Todd Siel, General Manager

As I navigate through my first spring here at the LRNRD, there are numerous projects, programs, and services we are attending to, but here are three current areas of interest I want to highlight:

- Nebraska Bostwick:** the signing of our agreement supporting the installation of automated gates on the Franklin Canal was a truly historic moment. (See photo below.) This joint effort is hopefully just the beginning of further cooperative relationships leading to future projects benefitting irrigators in the LRNRD.
- NCORPE – Republican River Compact:** we are not pumping this spring from our augmentation wells south of North Platte and it's possible no pumping will be needed at all in 2018 for compact compliance. Also, groundwater levels have risen across the NCORPE property since we last pumped in May 2017.
- Harlan County Lake:** for the fourth consecutive year, the lake is storing more water than the previous year. In terms of elevation, the lake has risen from 1,927.81 in January 2014 to the current level of 1,940.08 (as of April 1, 2018).

It's nice to have some positive water news as we prepare for this year's irrigation season!

# CREP ENROLLMENT OPEN FOR IRRIGATED GROUND!

Are you looking for an alternative option for your irrigated acres, but CRP rates don't stand up? There has never been a better time to enroll your irrigated acres into the Conservation Reserve Enhancement Program (CREP). This is a joint program between the Farm Service Agency (FSA) and the Nebraska Department of Natural Resources (NDNR) that pays irrigated rental rates to plant CRP on pivots and gravity irrigated fields (pivot corners can also be included).

CREP fields are planted into a CRP warm season grass mix and can be enrolled at any time throughout the year. To qualify, the fields must have been farmed and irrigated 4 out of 6 years between 2008-2013. The land does **NOT** have to be highly erodible (HEL) to qualify. CREP contracts are 10 or 15 years in length and allow managed haying and grazing with FSA approval.

**What does it pay?** CREP pays an annual rental payment every October (see table). In addition, FSA provides 50% cost-share on grass and forb establishment, which the NDNR matches (these combine for 90-100% cost share).

**Are there additional incentives available?** CREP enrollments within Franklin, Furnas, and Harlan Counties are eligible for additional incentives: **CREP Signup (\$50/acre)** and **CREP Establishment (up to \$25/acre)**. Incentives are offered by the Nebraska Game and Parks Commission (NGPC) and Pheasants Forever (PF). These counties are within the South-Central Focus on Pheasants (SCFOP) Area, a priority area identified by the NGPC's Berggren Pheasant Plan as an area of important habitat for up-land game birds.

Additionally, public hunting access is **NOT** required to participate in CREP or to receive SCFOP incentives. For those willing to allow walk-in hunting access, additional incentives (CRP= \$8/acre/year) are available through NGPC's Open Fields and Waters (OFW) Program.

## Adventure Camp about the Environment

Nebraska middle school students are invited to attend Adventure Camp about the Environment (ACE). ACE, hosted by Nebraska's NRDs, is held at the State 4-H Camp near Halsey, NE, from June 10th-13th. Camp Cost: \$215.00. The LRNRD awards two grants to students within the district. Grants are awarded to the first two applications received.

Students experience the great outdoors while exploring and learning about the environment. They will learn outdoor survival skills, interpret weather maps, identify tree species and animal tracks at camp. Campers will also get the opportunity to go tubing, try archery, zip line, build water rockets, and much more. They will take home a better awareness of possible careers in natural resources.

## 2018 LRNRD Cap Set At 13"

The 2018 district-wide allocation has been set at 13" for All certified effective irrigated acres. These inches can only be used if you have 13" of allocation to use. **Penalties will be applied for over usage.** The LRNRD Board of Directors has established a 13" hard cap for years designated as a compact call year by the Department of Natural Resources. This is the first year for the new allocation period. You are allowed to carry over up to 9 inches.

## Chemigation

June 1st is the deadline for chemigation permit renewals. The renewal fee is \$15. After June 1st they will be considered a new permit and will be charged \$50. All pivot irrigated fields that utilize chemigation are required to have a permit.

## Pooling

Pooling arrangements must be completed by June 1st for the 2018 irrigation season. Existing arrangements will continue unless written cancellation is received by June 1st. ## June 1st Deadline for Occupation Tax Exemption

LRNRD Occupation Tax Exempt forms need to be completed if you are paying irrigated taxes on certified irrigated acres and don't plan to irrigate part or all of these acres in 2018. If you do not have irrigated acres or you plan on irrigating all of your irrigated acres in 2018, you do not need to complete this form. If you would like to exempt acres, the form must be submitted by **June 1, 2018**.
