Clements will travel to Fort Collins, CO to speak at the Four States Water Conference on January 16th he will talk about

the N-CORPE project. A copy of the Manager's report is in the minute book.

Mike also updated the board on the N-CORPE Project. Phase one wells are expected to be operational by late January. Phase two should still be sometime in late February. Construction delays involved boring under the natural gas pipeline and in December when we had extreme cold weather, they could not pour concrete. We are still on track to be able to pump 50,000AF this year.

Bryan reported the LRNRD Static Water Level Changes from 1979 – 2013. A full copy of the Assistant Manager's report is in the minute book.

Jerry Kovarik, gave the NRCS report and updated the board on EQIP, AWEP, CStP and lastly the Working Agreements, Mutual Agreements and Acknowledgements of Section1619 Compliance between the LRNRD and NRCS.

Nebraska Game and Parks Commission has a Service Contract with the LRNRD on a yearly basis this is reviewed. The NRD received \$200 per month plus postage.

Motion #8 by Matt Harrison seconded by Toby tenBensel to approve Amendment No. 4 Cooperative Agreement between the Nebraska Game and Parks Commission and the Lower Republican Natural Resources District. Mike Clements presented the Change in Location of Certified Acres on Contiguous Property.

Motion #9 by Tim Kahrs seconded by Nelson Trambly to approve all Change in Location of Certified Acres on Contiguous Property: Andrew Meyer, Jerry Fouts, MKB Partnership (Kirk Gardels), Lyle Martin, Douglas R. Walker. Motion Carried. Ayes 10 –Toby tenBensel, Nelson Trambly, Brad Wulf, Clark Andrews, Dave Bartels, Bill Bose, Matt Harrison, Terry Hoit, Tim Kahrs, Marlin Murdoch. Nays 0. Absent 1 Roger Nelson.

Discussion was held on implementing pooling of irrigated (effective) acres for the remainder of the current allocation period (2014-2017) and to have a water use limit on pooled and non-pooled acres. Landowners would have the option to pool all or some of their certified (effective) acres as long as they do not exceed the water use allowed. Pooling options includes: one pool, multiple pools or not pooling at all. Pooling will only be allowed in your home county or in adjacent counties. There will be a sign-up deadline of May 1<sup>st</sup>, to submit pooling plans to the NRD. Pooling plans would remain the same unless changes are made by May 1<sup>st</sup> of each year.

Motion #10 by Clark Andrews seconded by Toby tenBensel to implement pooling of irrigated acres for the remainder of the current allocation period 2014-2017 and to have an 11" per acre limit on pooled acres and a 12" per acre limit on non-pooled acres for the 2014 irrigation season. Motion failed. Ayes 4 – Clark Andrews, Bill Bose, Marlin Murdoch, Toby tenBensel. Nays 6 – Dave Bartels, Matt Harrison, Terry Hoit, Tim Kahrs, Nelson Trambly, Brad Wulf. Absent 1 Roger Nelson.

Motion #11 by Dave Bartels seconded by Clark Andrews to implement pooling of irrigated acres for the remainder of the current allocation period 2014-2017 and to have a 10½" per acre limit on pooled acres and a 11½" per acre limit on non-pooled acres for the 2014 irrigation season. Motion carried. Ayes 9 – Brad Wulf, Clark Andrews, Dave Bartels, Bill Bose, Matt Harrison, Tim Kahrs, Marlin Murdoch, Toby tenBensel, Nelson Trambly. Nays 1 - Terry Hoit. Absent 1 Roger Nelson.

The board discussed setting a public hearing date of February 13<sup>th</sup>, 2014 at 1:30PM at the Johnson Center.

Motion#12 by Nelson Trambly seconded by Tim Kahrs to set the Public Hearing date for February 13, 2014 at 1:30 pm at the Johnson Center in Alma. NRD Manager's from the Upper, Middle and Lower Republican received a letter from DNR stating they are predicting dry conditions again this year. The forecasted two-year average for 2013-2014 is negative balance of 17,370AF. Mike explained that we have until January 31<sup>st</sup>, 2014, to submit our plan to implement the necessary management actions for the upcoming year. A copy of this letter is in the minute book.

Comments from the public: Dan Hughes, Venango, NE introduced himself to the board. He is running for Nebraska Legislature District 44.

Motion #13 by Bill Bose seconded by Toby tenBensel to approve the Rural Water Treasurer's report as presented.

Chairman admonished board that this is the only subject that can be discussed in closed session. Motion #15 by Clark Andrews seconded by Matt Harrison move that the Board come out of Executive Session at 4:23 p.m. and declare that no actions of the board, official or unofficial, were taken during said Closed Session. Motion carried. Ayes 10 –Matt Harrison, Terry Hoit, Tim Kahrs, Marlin Murdoch, Toby tenBensel, Nelson Trambly, Brad Wulf, Clark Andrews, Dave Bartels, Bill Bose. Nays 0. Absent 1 Roger Nelson.
