Mike Clements gave the NCORPE update. All wells have been shut down. Now that the investment company has seen what the NCORPE is capable of pumping, they are looking at taking the money that was used for interim financing and putting it into bonds so we can lower our payments and receive interest.

Mike Clements presented the board with a Letter of Engagement with Bruning Law Group. David Cookson and Katie Spohn will now be representing the LRNRD. A copy of this letter is in the minute book.

Mike Clements discussed the Republican River Basin-wide Plan Stakeholder Advisory Committee Meeting that was held on March 31. This meeting was organized to provide an opportunity to introduce the basin-wide water management planning process, participants and timeline. They discussed goals, objectives and the groundwater and surface water controls from the current Integrated Management Plans (IMPs). The group will begin to develop goals for the Basin-wide Plan (BWP). There are 46 Stakeholders on the Advisory Committee.

Roger Nelson will be attending the State Envirothon in Cozad on Wednesday, April 29.

There was no Rural Water update.

Bostwick Irrigation District has approached N-CORPE about potentially purchasing water from N-CORPE. Bostwick is still in the discussion process with N-CORPE.
