The Republican River Basin-Wide Plan is nearing completion after four years, both the NDNR and the NRD's have confidence that the Basin-Wide planning process will be completed near the end of this summer. Southern Valley FFA students Aubrey Warner, Diné Hutchens and Haley Witte highlighted the FFA programs and activities. The SV chapter placed 35th out of 105 in the State Land Judging contest. They went to National Land Judging contest in Oklahoma and placed 50th. The FFA is asking for donations to help cover expenses. Jon Lechtenberg, is the Southern Valley FFA instructor.

<u>NARD Update:</u> NRD Managers' tour is June 11th & 12th, both the Lower Platte South NRD and the Nemaha NRD will host and lead the tour. Roger Nelson circulated information on two local teams that participated at Envirothon. Southern Valley place 2nd and Arapahoe placed 3rd at the event.

NCORPE Update: Replacement and repairs are being made on a beaver dam, culvert and a valve at NCORPE. UNL Dr. Thompson did an economic study on NCORPE. According to the study, NCORPE is providing benefits of \$35 million per year in keeping the economy going.

Other Business: There was no other business to discuss.
