Bryan Lubeck discussed with the board the Fall 2008 Static Water Level Measurements and the No-till Cover Crops Research Field Day near Bladen he attended. There were twenty different crops, in twenty-five different plots. The impressive part of the demonstration was the water sensors and they showed the water use for each of the cover crops.

Senator Tom Carlson talked to the board briefly about vegetation management and how he is going to ask for a two year extension for the work and more funding. Senator Carlson said the Governor is okay with the extension, but Carlson needs to convince the legislature. Tom would like to come up with a believable, appropriate estimate of water saved to present to the legislature.
