Chairperson Nelson Trambly called the regular monthly meeting of the Lower Republican NRD Board of Directors to order at 8:00 p.m.

Nelson Trambly informed the audience of the Open Meetings Laws posters posted in the meeting room.

Motion #1 by Brad Wulf seconded by Matt Harrison to accept the board minutes as presented from the February board meeting. Motion carried. Roll Call – 9 Clark Andrews, Dave Bartels, Matt Harrison, Terry Hoit, Brian Holtze, Jim Moore, Roger Nelson, Nelson Trambly, Brad Wulf. Nays – 0. Absent - 2 Bill Bose, Marlin Murdoch.

Motion #2 by Jim Moore seconded by Brad Wulf to accept the February treasurer's report as distributed. Motion carried. Roll Call – 9 Dave Bartels, Matt Harrison, Terry Hoit, Brian Holtze, Jim Moore, Roger Nelson, Nelson Trambly, Brad Wulf, Clark Andrews. Nays – 0. Absent - 2 Bill Bose, Marlin Murdoch.

The staff reports had been distributed prior to the meeting and are in the minute book. Michael Clements presented the idea of the LRNRD having an Annual Water Conference. Several NRD's already have one of their own conferences and Mike believes it would be a benefit to our District. Michael Clements updated the board on the Arbitration Schedule. Bryan Lubeck discussed the nitrate sampling from the district and posed questions from the board. A copy of this report is in the minute book.

Bill Bose and Marlin Murdoch entered at 8:10 p.m.

Nick Simonson gave the NRCS report.

Traci Witthuhn presented the Republican River Basin Coalition Report. The NRRMDA meeting will be April 3rd in Imperial. There will be a Coalition meeting that same day.

Shirlee Poyser gave the LRNRD Wellness Plan report. A copy of this report is in the minute book.

Motion #3 by Roger Nelson seconded by Terry Hoit to approve the LRNRD to participate in the NARD Wellness Program and approve paying the employee portion of the blood chemistry profile. Motion carried. Roll Call – 11 Bill Bose, Matt Harrison, Terry Hoit, Brian Holtze, Jim Moore, Marlin Murdoch, Roger Nelson, Nelson Trambly, Brad Wulf, Clark Andrews, Dave Bartels. Nays – 0. Brad Edgerton, Frenchman Cambridge Irrigation District, talked to the board about water transfers and he agrees with the LRNRD that transfers should not be allowed.

Mike Clements reported that DNR has changed their policy on inactive wells. DNR now requires that wells only have to have a water tight cover but do not have to have the pump removed. Mike asked the board if they want to change our rules to reflect the changes that DNR has made. Kristi Coe feels that a meter needs to be present so we know that the well is definitely not being used.

Motion #4 by Brad Wulf seconded by Matt Harrison to update our rules and regulations to adhere to the new DNR policy pertaining to inactive wells. Once approved all inactive wells that have the pump and pumping column removed do not have to have a flow meter. If the pump and pumping column are left in place the well can still be changed to inactive status but must have a flow meter and must adhere to existing requirements pertaining to inactive wells. Mike Clements briefly talked about the AWEP (Agricultural Water Enhancement Program). The AWEP proposal combines federal and local funds to supplement temporary dryland conversion periods. In addition, AWEP offers a partnership to reduce water consumption and related depletions to the Republican River surface water flows in the LRNRD. This conversion program would complement a basin wide effort to reduce irrigated acres, promoting stream flow sustainability. The AWEP Program will be submitted to NRCS officials for final approval on April 1st. Starting in fiscal year 2009-2010, Mike asked the board to budget \$100,000 over the next four years for the AWEP program.

Motion #7 by Bill Bose seconded by Brian Holtze to contribute \$100,000 over the next 4 years to the AWEP Program. Motion carried. Roll Call – 11 Jim Moore, Marlin Murdoch, Roger Nelson, Nelson Trambly, Brad Wulf, Clark Andrews, Dave Bartels, Bill Bose, Matt Harrison, Terry Hoit, Brian Holtze. Nays – 0. Absent - 0.

Roger Nelson attended an NARD meeting in Lincoln. Roger feels the relationships of the NRD's are lots better. Issues of the LRNRD are now becoming other NRD's issues. NRD's are starting to realize what the LRNRD has been through. Husker Harvest Days was discussed as well as the Envirothon. The NARD November board meeting will be at the LRNRD.

The Executive Committee met and has been working on the AWEP Proposal.

Bryan Lubeck reported that groundwater testing in the Groundwater Management Area will start next week.

There was no Groundwater Management Committee report.

There was one approved Application for a Permit to Construct a Well.

There were no Wild NE Applications.

Mike Clements was asked by Trailblazer RC&D if he would be the voting alternate for the LRNRD. This is if LRNRD representatives are not able to attend Mike can vote for the district.
